RESOLUTION CONGRATULATING AND COMMENDING
THE COUNTRY'S OUTSTANDING POLICE OFFICERS
IN SERVICE (COPS) OF 2013, AWARDED BY THE
METROBANK FOUNDATION, INC., THE ROTARY
CLUB OF NEW MANILA EAST AND THE
PHILIPPINE SAVINGS BANK (PSBANK)

WHEREAS, the search for the Country's Outstanding Police Officers in Service (COPS) is an annual recognition program jointly undertaken by the Metrobank Foundation, Inc., the Rotary Club of New Manila East and PSBank, which aims to honor models of professionalism, competence, dedication and integrity among the 148,000 members of the Philippine National Police (PNP);

WHEREAS, the search, which is an expression of the civilian sector's appreciation and gratitude to the efforts of the PNP in maintaining the peace and order situation in the country, seeks to honor the gallant men and women in the

police force for their consistent outstanding contributions in preventing and solving crime through community work and mobilization, and emphasizes the need to situate the punitive aspect of law enforcement with the task of community relations, and promote police work as a shared responsibility between the police officers and the community;

WHEREAS, COPS serves as the social contract of the Metrobank Foundation, Inc., the Rotary Club of New Manila East and PSBank to the police force that will advance the welfare of the PNP and contribute in the realization of the Integrated Transformation Program of making the institution a highly capable, effective and credible police service working in partnership with a responsive community;

WHEREAS, the competition awards a maximum of ten (10) winners who shall be chosen from among all the Police Commissioned Officers with the rank of Police Inspector to Police Superintendent and Police Noncommissioned Officers with the rank of Police Officer 1 to Senior Police Officer 4;

WHEREAS, the Philippine Senate proudly joins the Metrobank Foundation, Inc., the Rotary Club of New Manila East and PSBank in congratulating and commending the Police Officers who have actively solicited, mobilized, involved and organized the community to become fellow vanguards of the community through the 2013 Metrobank Foundation Search for the Country's Outstanding Police Officers in Service;




