A. ON AMENDING OR OTHERWISE REPEALING REPUBLIC ACT NO. 10912 OTHERWISE KNOWN AS THE CONTINUING PROFESSIONAL DEVELOPMENT LAW (CPD)

1. Senate Bill No. 267 – AN ACT REPEALING REPUBLIC ACT NO. 10912, OTHERWISE KNOWN AS THE “CONTINUING PROFESSIONAL DEVELOPMENT ACT OF 2016” (*Introduced by Sen. Ralph G. Recto; Referred to Civil Service*)
