Joel Villanueva; Referred to Civil Service; and Government Corporations and Public Enterprises)*

Senate Bill No. 738 – AN ACT LOWERING THE COMPUSARY AND OPTIONAL RETIREMENT AGE OF GOVERNMENT EMPLOYEES, AMENDING FOR THE PURPOSES SECTIONS 13 (b) AND 13- A OF REPUBLIC ACT NO. 8291, OTHERWISE KNOWN AS THE GOVERNMENT SERVICE INSURANCE SYSTEM ACT OF 1997 *(Introduced by Sen. Sherwin T. Gatchalian; Referred to Civil Service; and Government Corporations and Public Enterprises)*
 4. Senate Bill No. 958 – AN ACT LOWERING OPTIONAL RETIRMENT AGE OF PUBLIC SCHOOL TEACHERS FROM SIXTY (60) YEARS OLD TO FIFTY-FIVE (55) YEARS OLD, AMENDING FOR THE PURPOSE SECTION 13-A OF REPUBLIC ACT NO 8291, OTHERWISE KNOWN AS THE “GOVERNMENT SERVICE INSURANCE SYSTEM ACT OF 1997” *(Introduced by Sen. Sonny Angara; Referred to Civil Service; and Government Corporations and Public Enterprises)*
 5. House Bill No. 5509 – AN ACT LOWERING THE OPTIONAL RETIREMENT AGE OF GOVERNMENT WORKERS FROM SIXTY (60) TO FIFTY-SIX (56) YEARS, AMENDING FOR THE PURPOSE SECTION 13-A OF REPUBLIC ACT NO. 8291, OTHERWISE KNOWN AS “THE GOVERNMENT SERVICE INSURANCE SYSTEM ACT OF 1997” *(Introduced by Reps. Garbin, Castro (F.L.) et. al.; Referred to Civil Service; and Government Corporations) **approved on 3rd Reading at the House of Representatives*
