Sonny Angara);

SBN 315 entitled, *“An Act Prohibiting Discrimination on the Basis of Ethnicity, Race, Religion or Belief, Sex or Gender or Sexual Orientation, Language, Disability, Educational Attainment, and Other Forms of Discrimination, Providing Penalties Therefor, and for Other Purposes”* (Sen. Grace Poe);

SBN 1214 entitled, *“An Act Prohibiting Discrimination on the Basis of Age, Sex, Civil Status, Color, Economic Status, Ethnicity, Medical Condition, Physical Disability, Political Opinion or Affiliation, Race, or Religious Belief, Providing Penalties Therefor and for Other Purposes”* (Sen. Joel Villanueva); and

SBN 1675 entitled, *“An Act Prohibiting Discrimination on the Basis of Age, Racial or Ethnic Origin, Religious Belief or Activity, Political Inclination or Conviction, Social Class, Sex, Gender, Sexual Orientation, Gender Identity and Expressions, Marital or Relationship Status, Disability, HIV Status, Profession or Occupation, Health Status or Medical History, Language, Physical Features, and Other Status, and Providing Penalties Therefor”*.
