Please be informed that the *Committee on Civil Service, Government Reorganization, and Professional Regulation* joint with the *Committees on Basic Education; Higher, Technical and Vocational Education; Ways and Means; and Finance* will conduct a **virtual Public Hearing on January 25, 2023 (Wednesday), at 11:00 a.m., via Cisco Webex Teleconference at Sen. Tañada Room**, to discuss the following legislative measures:

A. TEACHING SUPPLIES ALLOWANCE ACT
