- **Senate Bill No. 236** - AN ACT REINSTATING THE MANDATORY RESERVE OFFICERS TRAINING CORPS (ROTC) PROGRAM IN ALL UNDERGRADUATE DEGREE OR DIPLOMA PROGRAMS IN PUBLIC AND PRIVATE TERTIARY-LEVEL EDUCATIONAL INSTITUTIONS *(by: Sen. Robinhood C. Padilla)*
