**SBN. 2399** “AN ACT MANDATING THE ESTABLISHMENT AND IMPLEMENTATION OF THE PARENT EFFECTIVENESS SERVICE PROGRAM TO STRENGTHEN PARENTAL INVOLVEMENT IN THEIR CHILDREN’S DEVELOPMENT AND LEARNING AND APPROPRIATING FUNDS THEREFOR.”
