BIDS AND AWARDS COMMITTEE (BAC)

CY 2012 ACCOMPLISHMENT REPORT

As mandated by Republic Act 9184 (Government Procurement Reform Act), the Senate Bids and Awards Committee (BAC) was reconstituted under Special Order No. 2012-006 (OSP) dated January 3, 2012. The committee conducted a total of 78 meetings, awarded 22 contract and other items under public bidding, and acted upon 168 various requests under the alternative mode of procurement.

I. ACCOMPLISHMENTS

For 2012, the BAC accomplished the following:

A. Competitive bidding for various service contracts and other items

From January to June, the BAC conducted pre-procurement and pre-bidding conferences for 18 service contracts and other items. During the said period, the committee awarded the following: CY 2012 Security Guard Service; CY 2012 Canteen Concession and Catering Services; Printing and binding of "Record of the Senate" and "Journal of the Senate;" Supply and delivery of Various Firing Supplies; Subscription to Websense Web Filter (seat licenses); Supply and delivery of Various Inks and Toners; CY 2013 Subscription to Local/International Newspapers and Magazines; and CY 2013 Subscription to Local/International Journals and Reviews.

From July to December, the BAC conducted competitive biddings on various service contract requirements for 2013, including the Supply of labor and materials for the construction of committee rooms at the 2nd floor, Core 'C' GSIS Building and the Supply of labor and materials for the construction of extension offices of Senators located at the 5th floor, Core 'C' of the same building. In compliance with R.A. 9184, these projects were advertised in the Philippine Daily Inquirer and likewise posted in the Government Electronic Procurement System (GEPS) and in the Senate bulletin boards.

As of December 31, 2012, the Office of the Senate President approved twenty-two BAC Resolutions as shown below:

For the CY 2013 Supply of gasoline and diesel fuel using fleet card system, the BAC declared two (2) failed biddings and two (2) failed negotiated procurement. The BAC considered the recommendation of the end-user for a third negotiated procurement.


B. Alternative Mode of Procurement (AMP)

Article XVI (Alternative Mode of Procurement), Sec. 48 of R.A. 9184 provides for the application of the alternative modes of procurement for goods subject to the approval of the head of procuring entity.

Pursuant to said provision, the BAC recommended 168 requests for AMP. Out of these, 131 were awarded to be purchased through "Shopping"; nine (9) under "Direct Contracting"; 19 for Negotiated Procurement with PS-DBM; and two (2) were purchased under "Small Value Procurement"; and five (5) requirements for the 2nd floor committee room project still pending procurement.

C. Meetings of the BAC

The BAC held a total of 78 meetings in CY 2012.



YEAR

Per record of the BAC Secretariat, the BAC conducted a total of forty-nine (49) pre-procurement conferences attended by the end-users. Some services went through several pre-procurement meetings due to meticulous review of the proposed Scope of Works and other technical requirements by the BAC. Thirty-seven (37) pre-bidding conferences were also held and attended by the end-users, bidders and other interested parties.

D. Sale of Bid Documents

DBM Budget Circular No. 2007-3 dated November 29, 2007 pertaining to "Amendments to Certain Provisions of Budget Circular (BC) No. 2004-5A RE: Guidelines on the Grant of Honoraria and Overtime Pay to Government Personnel Involved in Government Procurement" specifically item 3.1.1 provides that proceeds from sale of bid document is among the sources of the BAC from which to pay its honorarium and other expenses. Since 2005, the income of the BAC has been remitted by the Cash Management Service to the Bureau of Treasury.

From the record furnished by the Legislative Accounting Service, the Senate through the Bids and Awards Committee generated the following amount representing the sale of bid documents and other income.
