

# Pasay City BIDS AND AWARDS COMMITTEE (BAC)

#### **CY 2015 ACCOMPLISHMENT REPORT**

As mandated by Republic Act 9184 (Government Procurement Reform Act), the Senate Bids and Awards Committee (BAC) was reconstituted under Special Order No. 2015-004 (OSP) dated January 12, 2015. The objective is to provide the Senate with an efficient and effective management of the procurement of supplies, materials, equipment, repairs and other services.

In CY 2015, the committee awarded a total of twenty- two (22) undertakings through public bidding wherein corresponding BAC Resolutions were prepared and subsequently approved. Out of the twenty- two (22), Purchase Orders/ Job Orders were prepared for ten (10) projects with assistance from the Property and Procurement Service while contracts were issued on the remaining twelve (12) services/ projects through the assistance provided by the Office of the Senate Legal Counsel.

#### I. ACCOMPLISHMENTS

The accomplishments of the BAC in CY 2015 are divided into four (4) quarters with corresponding Approved Resolutions, Budget for the Contract (ABC) and Contract Amount as follows:





#### G. AMENDMENTS TO THE ANNUAL PROCUREMENT PLAN (APP)

In 2015, as requested by various offices, the BAC recommended a total of 34 amendments to the Project Procurement Management Plans (PPMPs) of the Senate Secretariat and offices of Senators. Said requests were referred to the Legislative Budget Service for review prior to consolidation to the APP. The updated APP was submitted and subsequently approved by the Office of the Senate President in accordance with Section 7 of the IRR of RA 9184. All approved amendments were reflected in the Senate Annual Procurement Program (APP).

#### H. MEETINGS OF THE BAC

A total of 83 meetings for CY2015 were conducted by the BAC which is 11 meetings higher than the previous year on account of the increase in the number of projects during the year.



The BAC records show that said meetings were attended by end-users and other interested parties most of whom witnessed the BAC proceedings up to the submission and opening of bids.

#### I. INCOME OF THE SENATE BAC

Consistent with the provision under DBM Budget Circular No. 2007-3 dated November 29, 2007 re Amendments to Certain Provisions of Budget Circular (BC) No. 2004-5A RE: Guidelines on the Grant of Honoraria and Overtime Pay to Government Personnel Involved in Government Procurement, specifically item 3.1.1 which provides "proceeds from sale of bid documents..." as among the sources of the BAC from which to pay its expenses.

For 2015, from the data furnished by the Legislative Accounting Service, the Senate Bids and Awards Committee generated a total of Three Hundred Fifty-Two Thousand Three Hundred Fifty Pesos and Sixteen Centavos (Php352,350.16) representing the sale of bid documents.



The students were given orientation on the procurement law and were made to assist during the meetings of the BAC. They personally experienced how the biddings were conducted in the Senate. They were also trained to perform receiving / releasing general communications such as advisories, special orders, among others, proper telephone etiquette, grooming, recording entries in the Abstract of Bids and the logbooks, encoding, filing, preparation of invitation to BAC meetings/ memorandums, and use of office equipment such as the facsimile and photocopier machines. They transcribed the proceedings of the BAC meetings as part of their training.



#### III. ACTIONS TAKEN BY THE BAC

In the procurement of all Senate undertakings, steps were taken by the committee to efficiently manage the bidding process through:

- 1. Advance preparation of the Abstract of Bids for signature of members during the opening of bids;
- 2. Signing of the Abstract of Bids immediately after an award is made;
- 3. Early preparation of BAC Resolutions for signature of members;
- 4. Close monitoring of the BAC Resolutions from the time of preparation until its approval;
- 5. Close coordination with the Office of the Senate Legal Counsel who promptly acted on the requests for contract preparations; and
- Close supervision on the preparation of Purchase Orders, Job Orders and documentation of delivered items with the Property and Procurement Service whose assistance were held valuable in the purchase of the requested items.

Moreover, as instructed by the BAC, the Secretariat continuously coordinates with the Government Procurement Policy Board (GPPB) by way of letter- queries regarding clarification on provisions of the IRR of R.A. 9184. To date, four (4) letters were sent to GPPB on the following matters:

- 1. Query No. 1
  - a) on purchase of books only available online using credit card
  - b) on how to procure research study for official use from local and foreign sources
  - c) on how to acquire /procure services of local or foreign research company
- 2. Query No. 2
  - a) whether a procuring entity has the option to choose any form of Bid Security
  - b) whether not to include the Bid Securing Declaration as one of acceptable forms
- 3. Query No. 3 on Retention Money through issuance of Non-Policy Opinion (NPO) No. 67-2015
- 4. Query No. 4 on Business Tax Returns through issuance of NPO No. 144-2015

Out of the four (4) letters sent to GPPB, the Senate BAC received replies to Query No. 3 and Query No. 4.

The committee members were also furnished by the BAC Secretariat with copies of latest provision/ GPPB Non- Policy Opinion/s or any revision(s) in the IRR as update. The BAC continue to revisit the list of documentary requirements and the Instruction to Bidders for Goods and Infrastructure covering the regular biddings and negotiated procurements for review or revision as needed.

The Committee also suggested to end-users to consider entering into multiyear contracts for various service requirements subject to the approval of the Department of Budget and Management and in accordance with existing rules.
