

### EXPLANATORY NOTE

For more than four decades, ground forces have been deployed to fight terrorist organizations and extremist groups in all parts of the country. With meager benefits and incentives, these soldiers risk their lives without complaint. These ground forces has to carry their personal belongings, food and service gear enduring prolonged physical and mental strain.

The AFP practice of granting pay based on the risks and hazards of a particular occupational specialty was based on American system of WW2 when large air and naval battles caused tremendous casualties to its air and naval forces.

The ground personnel receives a combat duty pay of P240.00 monthly while his counterpart in the Navy and Air Force is receiving a sea duty pay of 25% and flying pay of 50% of their base pay, respectively. The last increase of the Combat Duty Pay was made 22 years ago by virtue of Executive order No. 1017 dated March 22, 1985.

This proposed measure to increase the combat duty pay to 25% of the base pay, will bring back the seemingly fading respect of "field assignments". This will also augment their income, uplift their morale and encourage them to work beyond their call of duty. Moreover, soldiers will be able to procure on their own some of the vital individual equipment and amenities they need during the operations, especially which are not adequately or timely provided by the government.

I therefore appeal for the immediate enactment of this measure.



AN ACT  
INCREASING THE COMBAT DUTY PAY OF ALL OFFICERS AND ENLISTED  
PERSONNEL OF THE ARMED FORCES OF THE PHILIPPINES (AFP) FROM TWO  
HUNDRED FORTY PESOS (P240.00) PER MONTH TO TWENTY-FIVE PER CENTUM  
(25%) OF THEIR BASE PAY AND PROVIDING FUNDS THEREFOR

*Be it enacted by the Senate and House of Representatives of the Philippines in Congress assembled.*

**SECTION 1. *Short Title.*** - This Act shall be known as "*Combat Duty Pay Increase*".

**SECTION 2. *Declaration of Policy.*** - It is the paramount goal of the Armed Forces of the Philippines to protect the people, to secure the sovereignty of the State and maintain the integrity of the national territory.

Moreover, Section 5 of Article XVI of the Constitution provides for the professionalism in the armed forces and adequate remuneration and benefits of its members shall be a prime concern of the state.

**SECTION 3. *Increase in Combat Duty Pay.*** - the combat duty pay of all officers and enlisted personnel of the Armed Forces of the Philippines (AFP) from Two Hundred Forty Pesos (P240.00) per month to Twenty-five per centum (25%) of their base pay.

**SECTION 4. *Budget Appropriation*** - such amount as may be necessary to implement this Act for the current year shall be charged to the savings of the Department of National Defense (DND) and to the General Appropriations Act for the succeeding years.

**SECTION 5. *Implementing Rules and Regulations*** - As the lead agency, the DND shall, in coordination with the AFP shall promulgate the Rules and Regulations (IRR) of this Act within ninety (90) days after its effectivity.

**SECTION 6. *Separability Clause.*** - If any provision or part hereof is held invalid or unconstitutional, the remainder of the law or the provision not otherwise affected shall remain valid and subsisting.

**SECTION. 7. *Repealing Clause.*** - Any law, presidential decree or issuance, executive order, letter of instruction, administrative order, rule or regulation contrary to, or inconsistent with the provisions of this Act is hereby repealed, modified or amended accordingly.

**SECTION. 8. *Effectivity Clause.*** - This Act shall take effect fifteen (15) days after its publication in at least two (2) newspapers of general circulation.
