### AN ACT CREATING A BARANGAY TO BE KNOWN AS BARANGAY BANAWA-ENGLIS IN THE CITY OF CEBU

*Be it enacted by the Senate and House of Representatives of the Philippines in Congress assembled:*

1           SECTION 1. *Creation of Barangay Banawa-Englis.* – The sitios of  
2   Banawa and Englis are hereby separated from Barangay Guadalupe and  
3   constituted into a new barangay to be known as Barangay Banawa-Englis, City  
4   of Cebu.

5           Barangay Banawa-Englis will encompass the following puroks:

6           (a) Puroks in Sitio Banawa:

7           (1) Eskina Banawa (comprising the satellite market, Gullas Compound  
8   up to corner Suzara Street all along V. Rama Avenue);

9           (2) Verano Compound I;

10          (3) Verano Compound II;

11          (4) Falek Compound and Sundance Hills;

12          (5) Damiana's Compound;

1           The territorial boundary of Barangay Banawa-Englis shall be as follows:

2           From the East going South starting from the bridge at M. Velez Street  
3 to share common boundary with Barangay Capitol, which is the Guadalupe  
4 River going down and up to the bridge at B. Rodriguez Street.

5           Thence, turning right towards the West and starting from the bridge at  
6 B. Rodriguez Street, and passing along the same street up to the corner of  
7 Happy Valley Street, then turn left following the same street up to and across  
8 Rosalina Subdivision and thereafter, to share the existing boundaries of  
9 barangays Calamba, Labangon, Tisa and Buhisan.

10          Thence, again starting from the East at the Guadalupe Bridge and along  
11 M. Velez Street going West up to the corner of V. Rama Avenue, turn right  
12 towards the North and along V. Rama Avenue up to the corner of Suzara  
13 Street, turn left towards the West and along the same street to cut across and  
14 along the outer edges of Falek Compound at Sundance Hills down to and  
15 across the outer edges of Damiana's Compound up to the dry small creek.

16          Thence, following the Northward direction of the creek up to the  
17 portion directly behind the outer edges of the lots at Villa Salud Subdivision  
18 up to the junction of Quijada (Doña Modesta) and the unnamed street leading  
19 towards the Maria Luisa South Subdivision; thereafter to follow a westerly  
20 imaginary straight line up to the hills where the West-Northwest boundary  
21 lines of barangays Bulisan and Sapangdatu intersect.

22          SEC. 2. *Conduct and Supervision of Plebiscite.* – The Commission on  
23 Elections (COMELEC) shall conduct and supervise the plebiscite to be held in  
24 the area affected within thirty (30) days from the effectivity of this Act.

25          SEC. 3. *Barangay Officials.* – The first set of barangay elective  
26 officials of Barangay Banawa-Englis shall be elected in a special election to be  
27 conducted within sixty (60) days after the ratification by the majority of the  
28 votes cast in a plebiscite held in the areas affected.

1           SEC. 4. *Beginning of Corporate Existence of Barangay Banawa-*  
2 *Englis.* – The corporate existence of Barangay Banawa-Englis, City of Cebu  
3 shall commence upon the election and qualification of its punong barangay and  
4 majority of the members of its sangguniang barangay.

5           SEC. 5. *Seat of Barangay Government.* – The seat of Barangay  
6 Government of Barangay Banawa-Englis shall be located at the old Sitio  
7 Banawa.

8           SEC. 6. *Internal Revenue Allotment Shares.* – Barangay Banawa-  
9 Englis, City of Cebu shall be entitled to Internal Revenue Allotment shares  
10 pursuant to Section 285 of Republic Act No. 7160, otherwise known as the  
11 “Local Government Code of 1991”.

12           SEC. 7. *Appropriations.* – The amount necessary to conduct the  
13 plebiscite as provided for under this Act shall be charged against the  
14 Contingent Fund of the COMELEC.

15           SEC. 8. *Effectivity.* – This Act shall take effect upon its approval.
