**AN ACT
DECLARING THE TWENTY NINTH OF SEPTEMBER OF EVERY YEAR
AS A SPECIAL NONWORKING HOLIDAY IN THE MUNICIPALITY
OF BACOR, PROVINCE OF CAVITE IN CELEBRATION OF
THE "ARAW NG BACOR"**

Be it enacted by the Senate and House of Representatives of the Philippines in Congress assembled:

SECTION 1. In commemoration of the foundation of the Municipality of Bacoor, in the Province of Cavite, the Twenty-Ninth (29th) of September of every year is hereby declared as a "Special Nonworking Holiday" in the Municipality of Bacoor, Province of Cavite to be named as "Araw ng Bacoor";

SEC. 2. This Act shall take effect fifteen (15) days upon its approval and its publication in a newspaper of general circulation.
