AN ACT LIMITING THE TERM OF OFFICE OF THE REGULAR MEMBERS OF THE JBC

Be it enacted by the Senate and the House of Representatives of the Philippines in Congress assembled:

SECTION 1. Declaration of Policy. - It is hereby declared the policy of the 2 State to enhance the independence of the judiciary by insulating it from political 3 pressure and influence, especially in the nomination and selection of appointees 4 to the judiciary. 5 6 SEC.2. Regular Members. - For purposes of this Act and pursuant to Section 7 8 (2), Article VIII of the 1987 Constitution, the following are the regular members 8 of the Judicial and Bar Council, appointed by the President for a term of four 9 years with the consent of the Commission on Appointments: 10 11 a. Representative of the Integrated Bar of the Philippines; 12 b. Professor of Law; 13 c. Retired Member of the Supreme Court; and 14 d. Representative of the Private Sector. 15 16 SEC.3. Limitation. - A regular member of the Judicial and Bar Council who 17 has completed the service of his/her term of office shall no longer be eligible for 18 re-appointment to the same position in whatever capacity. 19 20 SEC.4. Separability Clause. - If any provision of this Act shall be declared 21 void or unconstitutional, any other provisions not affected thereby shall remain 22 in full force and effect. 23 24 25 SEC.5. Repealing Clause. - All laws, decrees, orders, rules and regulations, or parts thereof inconsistent with this Act are hereby repealed or amended 26 accordingly. 27 28 29 SEC.6. Effectivity. - This Act shall take effect fifteen (15) days after its publication in the Official Gazette or in at least two (2) newspapers of general 30 circulation. 31 32 Approved, 33 34
