Explanatory Note

Section 15 of Article II under the 1987 Constitution mandates that the State shall protect and promote the right to health of the people and instill health consciousness among them. Unfortunately, recent data proved otherwise. According to a report from the Department of Science and Technology in 2008, thousands of women in the Philippines are diagnosed with some form of gynecologic cancer each year and it is estimated that about one-third of them will succumb to their disease.¹ This is a national tragedy magnified by the fact that the most common gynecologic cancers - ovarian, uterine, and cervical cancer - have five-year survival rates exceeding 90% when diagnosed at their earliest stages.

Because early detection and treatment often mean the difference between life and death, it is important to increase awareness of the factors that put certain women at a higher risk of gynecological cancer. Because symptoms of such are vague and non-specific, women and their physicians often attribute them to more common conditions so that by the time the disease is diagnosed the cancer has often spread.

Although development of a screening test to detect all these forms of gynecological cancer remains a very active area of research, currently there is no definitive prevention strategy, but having regular examinations may decrease the overall risk of dying from cancer. It is clearly in the interest of advancing the public health for this State to commit itself to a widespread and sustained effort to increase awareness of gynecologic cancer among the general public. While gynecologic cancers are often asymptomatic, awareness can lead to early detection and successful treatment.

In view of the foregoing, the passage of this bill is earnestly sought.

ANACT

ESTABLISHING A GYNECOLOGIC CANCER PUBLIC EDUCATION AND AWARENESS CAMPAIGN, APPROPRIATING FUNDS THEREFOR, AND FOR OTHER PURPOSES

Be it enacted by the Senate and House of Representatives of the Philippines in Congress assembled:

SECTION 1. Short title.- This act shall be known and may be cited as the
 "Gynecologic Cancer Education and Awareness Act."

4 SEC. 2. Establishment of a public education and awareness campaign.- The 5 Department of Health (DOH) shall establish a public education and awareness campaign to 6 inform the general public about the clinical significance of gynecologic cancer and its public 7 health implications, including, at a minimum, the risk factors, symptoms, need for early 8 detection, and methods of treatment associated with gynecologic cancer.

SEC. 3. Functions of the campaign.- For the purposes of the public education and
 awareness campaign, the DOH Secretary shall, at a minimum:

provide for the development of printed educational materials and public service
 announcements in English and Spanish;

disseminate information for distribution to the public through such entities as the
 commissioner determines most appropriate to effectuate the purposes of this Act, including,
 but not limited to, local health agencies and clinics, physicians, health care facilities, county

offices on aging, pharmacies, libraries, senior citizen centers, and other community-based
 outreach programs and organizations;

3 3. post such information on the official Internet website of the DOH; and

4 4. take such other actions as the commissioner deems appropriate to enhance public
5 awareness of gynecologic cancer among members of the general public.

SEC. 4. Appropriations.- There is appropriated three million pesos (Php 3 M) from
the General Fund to the DOH to carry out the public education and awareness campaign
pursuant to this act.

11 SEC. 5. *Repealing Clause.*- Any laws, decrees, ordinances or rules and regulations 12 which are inconsistent with or contrary to the provision of this Act is hereby amended or 13 repealed.

SEC. 6. *Effectivity.-* This Act shall take effect fifteen (15) days after its complete
 publication in at least two (2) national newspapers of general circulation.
