

House Bill No. 4648, introduced by Representative Antonio H. Cerilles, entitled:







AN ACT CONVERTING THE PROVINCIAL ROAD WHICH STARTS  
FROM SINDANGAN IN ZAMBOANGA DEL NORTE AND  
TRAVERSES BAYOG TO POBLACION, LAKEWOOD IN  
ZAMBOANGA DEL SUR INTO A NATIONAL ROAD

*Be it enacted by the Senate and House of Representatives of the Philippines in  
Congress assembled:*

1       SECTION 1. The provincial road which starts from Sindangan in  
2       Zamboanga del Norte and traverses Bayog to Poblacion, Lakewood in  
3       Zamboanga del Sur is hereby converted into a national road.

4       SEC. 2. The Secretary of the Department of Public Works and  
5       Highways shall issue the necessary rules, orders and circulars to implement the  
6       provision of this Act.

7       SEC. 3. This Act shall take effect fifteen (15) days after its publication  
8       in a newspaper of general circulation.
