

Congress assembled:*

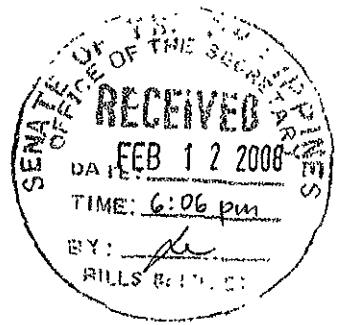
1 SECTION 1. The Antequera – San Isidro – Libertad (Tubigon)
2 Provincial Road traversing the municipalities of Antequera, San Isidro and
3 Tubigon, Province of Bohol is hereby converted into a national road.

4 SEC. 2. The Secretary of the Department of Public Works and
5 Highways shall issue the necessary rules, orders and circulars to implement the
6 provision of this Act.

7 SEC. 3. This Act shall take effect *fifteen (15) days* after its publication
8 in a newspaper of general circulation.

- 6 issue the necessary rules, orders and circulars to implement the provisions of this Act.
