Be it enacted by the Senate and House of Representatives of the Philippines in Congress assembled

1	SECTION 1. Section 14, paragraph (I) of Batas Pambansa Blg. 129, as
2	amended, is hereby further amended to read as follows:
3	"(I) [Forty-one] FORTY-THREE Regional Trial Judges
4	shall be commissioned for the Eleventh Judicial Region. There
5	shall be:
5	"[Six] FIVE branches with seats thereat for the Province
7	of Davao del Norte, with seats at Tagum, [Nabunturan,] and

1	"THREE BRANCHES FOR THE PROVINCE OF
2	COMPOSTELA VALLEY WITH SEATS AT NABUNTURAN,
3	COMPOSTELA, AND MABINI;"
4	"x x x."
5	SEC. 2. The Chief Justice of the Supreme Court, in coordination with
6	the Secretary of the Department of Justice, shall immediately include in the
7	Court's program the operationalization of two additional branches of the
8	Regional Trial Court in Compostela Valley Province, to be stationed at the
9	municipalities of Compostela and Mabini, the funding of which shall be
0	included in the annual General Appropriations Act.
1	SEC. 3. This Act shall take effect upon its approval.
