BY REPRESENTATIVE APOSTOL, PER COMMITTEE REPORT NO. 809

AN ACT CONVERTING AND DECLARING CERTAIN ROADS IN THE
SECOND DISTRICT, PROVINCE OF LEYTE INTO NATIONAL
ROADS

*Be it enacted by the Senate and House of Representatives of the Philippines in
Congress assembled:*

1 SECTION 1. (1) The San Miguel – Barugo – Tunga via Amahit
2 Calingaguig – Carigara via Binibihan – Capoocan via Barangay Manloy –
3 Leyte via coastal barangays; (2) MacArthur – La Paz; (3) Burauen – Albuera;
4 (4) La Paz – Julita – Tabontabon – Dagami via Digahunan; (5) Jaro – Barugo
5 via Pitogo; (6) Burauen – Tabontabon via Barangay Libas; and (7) Dulag via
6 Camote – Tabontabon Road are hereby converted into national roads.

7 SEC. 2. The Secretary of the Department of Public Works and
8 Highways shall issue the necessary rules, orders and circulars to implement the
9 provision of this Act.

10 SEC. 3. This Act shall take effect fifteen (15) days after its publication
11 in a newspaper of general circulation.
