





AN ACT CONVERTING THE EASTERN BOBONGAN – SOMINOT –
MIDSALIP – DUMINGAG PROVINCIAL ROAD TRAVERSING
THE MUNICIPALITIES OF RAMON MAGSAYSAY, SOMINOT,
MIDSALIP AND DUMINGAG, PROVINCE OF ZAMBOANGA DEL
SUR INTO A NATIONAL ROAD

*Be it enacted by the Senate and House of Representatives of the Philippines in
Congress assembled:*

1 SECTION 1. The Eastern Bobongan – Sominot – Midsalip – Dumingag
2 Provincial Road traversing the municipalities of Ramon Magsaysay, Sominot,
3 Midsalip and Dumingag, Province of Zamboanga del Sur is hereby converted
4 into a national road.

5 SEC. 2. The Secretary of the Department of Public Works and
6 Highways shall issue the necessary rules, orders and circulars to implement the
7 provision of this Act.

8 SEC. 3. This Act shall take effect upon its approval.
