- SECTION 1. The Leganes Sta. Barbara Provincial Road traversing the municipalities of Leganes and Sta. Barbara, Province of Iloilo is hereby converted into a national road.
- SEC. 2. The Secretary of the Department of Public Works and Highways shall issue the necessary rules, orders and circulars to implement the provision of this Act.
