EXPLANATORY NOTE

The Civil Code, Article 737, states that "the donor's capacity shall be determined as of the time of the making of the donation." The term "making" must be interpreted to mean "perfection" of the donation, otherwise if "making" means "giving", Art. 737 would in some cases be inconsistent with Art. 734 which states that "the donation is perfected from the moment the donor knows of the acceptance by the donee".

An example of the perceived inconsistency is: "an insane donor donates on January 1. Donee accepts on January 5. Donor regains sanity on January 7. Donor knows of donee's acceptance on January 8, at a time when he was sane (capacitated). In this case, if we interpret "making" as "giving", the donation would be avoidable because of the donor's incapacity at the time he "gave" his property to the donee. On the other hand, if we consider "making" as "perfection", the donation would be valid because at the time of "making" (perfection), both parties had full capacity".

To avoid this contradiction, the language of Article 737 must be changed to make it clear and consistent with other provisions of the Civil Code on Donations.

**AN ACT**  
**AMENDING REPUBLIC ACT NO. 386, ALSO KNOWN AS THE CIVIL**  
**CODE OF THE PHILIPPINES, ARTICLE 737, MAKING IT CONSISTENT**  
**WITH THE OTHER PROVISIONS UNDER THE TITLE ON DONATIONS**

*Be it enacted by the Senate and the House of Representatives of the Philippines in Congress assembled:*

Section 1. R.A. No. 386, also known as the Civil Code of the Philippines, Article 737, is hereby amended to read as follows:

“Art. 737 (The donor’s capacity shall be determined as of the time of the making of the donation) **AT THE TIME THE DONATION IS PERFECTED, BOTH THE DONOR AND THE DONEE MUST BE CAPACITATED.**”

Section 2. **Separability Clause.** - If any provision or part hereof, is held invalid or unconstitutional, the remainder of the law or the provision not otherwise affected shall remain valid and subsisting.

Section 3. **Repealing Clause.** - Any law, presidential decree, or issuance, executive order, letter of instruction, administrative order, rule or regulation contrary to, or inconsistent with, the provisions of this Act is hereby repealed, modified, or amended accordingly.

Section 4. **Effectivity Clause.** - This Act shall take effect fifteen (15) days after its publication in at least two (2) newspapers of general circulation.
