**AN ACT CONVERTING THE DAPA – UNION – GEN. LUNA ROAD,
PROVINCE OF SURIGAO DEL NORTE INTO A NATIONAL
SECONDARY ROAD**

*Be it enacted by the Senate and House of Representatives of the Philippines in
Congress assembled:*

1 SECTION 1. The Dapa – Union – Gen. Luna Road, Province of Surigao
2 del Norte is hereby converted into a national secondary road.

3 SEC. 2. The Secretary of the Department of Public Works and
4 Highways shall issue the necessary rules, orders and circulars to implement the
5 provision of this Act.

6 SEC. 3. This Act shall take effect fifteen (15) days after its publication
7 in a newspaper of general circulation.
