AN ACT CONVERTING THE UMUS MATAHA – TANDUAN – BOKI-PAWAN – LUPA-PULA PROVINCIAL ROAD IN THE MUNICIPALITY OF MAPUN, PROVINCE OF TAWI-TAWI INTO A NATIONAL ROAD

*Be it enacted by the Senate and House of Representatives of the Philippines in Congress assembled:*

1           SECTION 1. The Umus Mataha -- Tanduan -- Boki-Pawan -- Lupa-Pula  
2 Provincial Road in the Municipality of Mapun, Province of Tawi-Tawi is  
3 hereby converted into a national road.

4           SEC. 2. The Secretary of the Department of Public Works and  
5 Highways shall issue the necessary rules, orders and circulars to implement the  
6 provision of this Act.

7           SEC. 3. This Act shall take effect fifteen (15) days after its publication  
8 in a newspaper of general circulation.

*Be it enacted by the Senate and the House of Representatives of the Philippines  
in Congress assembled:*

1       SECTION 1. The Umus Mataha - Tanduan - Boki-Pawan - Lupa-Pula  
2 Provincial Road in the Municipality of Mapun, Province of Tawi-Tawi is  
3 hereby converted into a national road.

4       SEC. 2. The Secretary of the Department of Public Works and Highways  
5 shall issue the necessary rules, orders and circulars to implement the  
6 provision of this Act.

7       SEC. 3. This Act shall take effect fifteen (15) days after its publication in  
8 a newspaper of general circulation.
