AN ACT CONVERTING THE INTERIOR CIRCUMFERENTIAL ROAD
OF LANA O DEL NORTE, PROVINCE OF LANA O DEL NORTE
INTO A NATIONAL ROAD

*Be it enacted by the Senate and House of Representatives of the Philippines in
Congress assembled:*

1 SECTION 1. The interior circumferential road which starts from the
2 Iligan – Aurora National Highway at Iligan and traverses Tagoloan, Baloi,
3 Pantao – Ragat, Munai, Tangkal, Magsaysay, Tubod, Salvador, Sapad,
4 Nunungan and ends at Malabang – Tukuran National Highway at Sultan Naga
5 Dimaporo, Province of Lanao del Norte is hereby converted into a national
6 road.

7 SEC. 2. The Secretary of the Department of Public Works and
8 Highways shall issue the necessary rules, orders and circulars to implement the
9 provision of this Act.

10 SEC. 3. This Act shall take effect upon its approval.
