

The Committees on Public Works and Finance, to which was referred House Bill No. 1713, introduced by Representative Salvador H. Escudero III, entitled:



AN ACT CONVERTING THE CUMADCAD – SAN ISIDRO –
POBLACION PROVINCIAL ROAD IN THE MUNICIPALITY OF
CASTILLA, PROVINCE OF SORSOGON INTO A NATIONAL
ROAD

*Be it enacted by the Senate and House of Representatives of the Philippines in
Congress assembled:*

1 SECTION 1. The Cumadcad – San Isidro – Poblacion Provincial Road
2 in the Municipality of Castilla, Province of Sorsogon is hereby converted into a
3 national road.

4 SEC. 2. The Secretary of the Department of Public Works and
5 Highways shall issue the necessary rules, orders and circulars to implement the
6 provision of this Act.

7 SEC. 3. This Act shall take effect upon its approval.
