AN ACT CONVERTING THE ALFONSO LISTA - AURORA
PROVINCIAL ROAD IN THE MUNICIPALITY OF ALFONSO
LISTA, PROVINCE OF IFUGAO INTO A NATIONAL ROAD

*Be it enacted by the Senate and House of Representatives of the Philippines in
Congress assembled:*

1 SECTION 1. The Alfonso Lista - Aurora Provincial Road traversing
2 barangays Namillangan, Calupaan, San Juan, San Quintin, San Jose and San
3 Marcos in the Municipality of Alfonso Lista, Province of Ifugao is hereby
4 converted into a national road.

5 SEC. 2. The Secretary of the Department of Public Works and
6 Highways shall issue the necessary rules, orders and circulars to implement the
7 provision of this Act.

8 SEC. 3. This Act shall take effect fifteen (15) days after its publication
9 in a newspaper of general circulation.
