





**AN ACT CONVERTING THE PIÑAN - MUTIA PROVINCIAL ROAD
LINKING THE MUNICIPALITIES OF PIÑAN AND MUTIA,
PROVINCE OF ZAMBOANGA DEL NORTE INTO A NATIONAL
ROAD**

*Be it enacted by the Senate and House of Representatives of the Philippines in
Congress assembled:*

1 SECTION 1. The Piñan - Mutia Provincial Road linking the
2 municipalities of Piñan and Mutia, Province of Zamboanga del Norte is hereby
3 converted into a national road.

4 SEC. 2. The Secretary of the Department of Public Works and
5 Highways shall issue the necessary rules, orders and circulars to implement the
6 provision of this Act.

7 SEC. 3. This Act shall take effect fifteen (15) days after its publication
8 in a newspaper of general circulation.
