## AN ACT CONVERTING THE BACOLOD – MADALUM HIGHWAY INTO A NATIONAL ROAD

Be it enacted by the Senate and House of Representatives of the Philippines in Congress assembled:

1 SECTION 1. The road which starts from the Iligan - Aurora National 2 Highway at Bacolod and traverses Munai in the Province of Lanao del Norte 3 and Marawi - Cotabato National Highway at Madalum in the Province of 4 Lanao del Sur is hereby converted into a national road. 5 SEC. 2. The Secretary of the Department of Public Works and Highways shall issue the necessary rules, orders and circulars to implement the 6 7 provision of this Act. SEC. 3. This Act shall take effect upon its approval. 8 Approved,
