
**MR. PRESIDENT:**

AN ACT CONVERTING THE PROVINCIAL ROAD WHICH STARTS  
FROM IMELDA IN ZAMBOANGA SIBUGAY AND TRAVERSES  
BAYOG AND, DIPLO KUMALARANG TO LAPUYAN AND  
MARGOSATUBIG IN ZAMBOANGA DEL SUR INTO A  
NATIONAL ROAD

*Be it enacted by the Senate and House of Representatives of the Philippines in  
Congress assembled:*

1           SECTION 1. The provincial road which starts from Imelda in  
2 Zamboanga Sibugay and traverses Bayog and Diplo Kumalarang to Lapuyan  
3 and Margosatubig in Zamboanga del Sur is hereby converted into a national  
4 road.

5           SEC. 2. The Secretary of the Department of Public Works and  
6 Highways shall issue the necessary rules, orders and circulars to implement the  
7 provision of this Act.

8           SEC. 3. This Act shall take effect fifteen (15) days after its publication  
9 in a newspaper of general circulation.
