AN ACT CONVERTING THE PANIQUI – RAMOS ROAD IN THE MUNICIPALITIES OF PANIQUI AND RAMOS, PROVINCE OF TARLAC INTO A NATIONAL ROAD

Be it enacted by the Senate and House of Representatives of the Philippines in Congress assembled:

- SECTION 1. The Paniqui Ramos Road in the municipalities of Paniqui and Ramos, Province of Tarlac is hereby converted into a national road.
- SEC. 2. The Secretary of the Department of Public Works and Highways shall issue the necessary rules, orders and circulars to implement the provision of this Act.
- SEC. 3. This Act shall take effect fifteen (15) days after its publication in a newspaper of general circulation.
