



AN ACT CONVERTING THE SOCORRO - NUEVA ESTRELLA -
BARANGAY PAMOSAINGAN ROAD, PROVINCE OF SURIGAO
DEL NORTE INTO A NATIONAL SECONDARY ROAD

*Be it enacted by the Senate and House of Representatives of the Philippines in
Congress assembled:*

1 SECTION 1. The Socorro - Nueva Estrella - Barangay Pamosaingan
2 Road, Province of Surigao del Norte is hereby converted into a national
3 secondary road.

4 SEC. 2. The Secretary of the Department of Public Works and
5 Highways shall issue the necessary rules, orders and circulars to implement the
6 provision of this Act.

7 SEC. 3. This Act shall take effect fifteen (15) days after its publication
8 in a newspaper of general circulation.
