AN ACT CONVERTING THE CORRALES EXTENSION ST. TO PORT
ROAD (MACABALAN), CAGAYAN DE ORO CITY INTO A
NATIONAL ROAD

*Be it enacted by the Senate and House of Representatives of the Philippines in
Congress assembled:*

1 SECTION 1. The Corrales Extension St. to Port Road (Macabalan),
2 Cagayan de Oro City is hereby converted into a national road.

3 SEC. 2. The Secretary of the Department of Public Works and
4 Highways shall issue the necessary rules, orders and circulars to implement the
5 provision of this Act.

6 SEC. 3. This Act shall take effect fifteen (15) days after its publication
7 in a newspaper of general circulation.
