





AN ACT CONVERTING THE STA. CATALINA -- PAMPLONA  
PROVINCIAL ROAD IN THE PROVINCE OF NEGROS ORIENTAL  
INTO A NATIONAL ROAD

*Be it enacted by the Senate and House of Representatives of the Philippines in  
Congress assembled:*

1           SECTION 1. The Sta. Catalina -- Pamplona Provincial Road in the  
2 Province of Negros Oriental is hereby converted into a national road.

3           SEC. 2. The Secretary of the Department of Public Works and  
4 Highways shall issue the necessary rules, orders and circulars to implement the  
5 provision of this Act.

6           SEC. 3. This Act shall take effect upon its approval.
