AN ACT PROVIDING FOR THE CONVERSION OF THE LAND  
TRANSPORTATION OFFICE (LTO) EXTENSION OFFICE IN THE  
CITY OF CALAMBA, PROVINCE OF LAGUNA INTO A  
REGULAR DISTRICT OFFICE TO BE KNOWN AS THE LTO  
DISTRICT OFFICE AND APPROPRIATING FUNDS THEREFOR

*Be it enacted by the Senate and House of Representatives of the Philippines in  
Congress assembled:*

1           SECTION 1. The Land Transportation Office (LTO) Extension Office  
2 in the City of Calamba, Province of Laguna is hereby converted into a regular  
3 district office to be known as the LTO District Office.

4           SEC. 2. The Department of Transportation and Communications shall  
5 issue the necessary rules and regulations to implement the said conversion.

6           SEC. 3. The amount needed for the operationalization of a regular LTO  
7 District Office in the City of Calamba, Province of Laguna shall be included in  
8 the annual General Appropriations Act.
