

AN ACT CONVERTING THE ILAYA BARANGKA ELEMENTARY
SCHOOL IN BARANGAY BARANGKA ILAYA, CITY OF
MANDALUYONG INTO AN INTEGRATED SCHOOL TO BE
KNOWN AS ILAYA BARANGKA INTEGRATED SCHOOL AND
APPROPRIATING FUNDS THEREFOR

*Be it enacted by the Senate and House of Representatives of the Philippines in
Congress assembled:*

1 SECTION 1. *Conversion into an Integrated School.* -- The Ilaya
2 Barangka Elementary School in Barangay Barangka Ilaya, City of
3 Mandaluyong is hereby converted into an integrated school to be known as
4 Ilaya Barangka Integrated School.

5 SEC. 2. *Transfer of Assets and Liabilities.* -- All personnel, assets,
6 liabilities and records of the Ilaya Barangka Elementary School are hereby
7 transferred to and absorbed by the Ilaya Barangka Integrated School.

8 SEC. 3. *Appropriations.* -- The Secretary of Education shall
9 immediately include in the Department's program the operationalization of the
10 Ilaya Barangka Integrated School, the initial funding of which shall be charged

1 against the current year's appropriations of the Ilaya Barangka Elementary
2 School. Thereafter, the amount necessary for the continued operation of the
3 school shall be included in the annual General Appropriations Act.

4 SEC. 4. *Implementation.* – The Secretary of Education shall issue rules
5 and regulations that may be necessary to carry out the purpose of this Act.

6 SEC. 5. *Effectivity.* – This Act shall take effect fifteen (15) days after
7 its publication in the *Official Gazette*.
