and Cua (J.), entitled:



AN ACT ESTABLISHING A NATIONAL HIGH SCHOOL IN BARANGA
AGUHO IN THE MUNICIPALITY OF PATEROS, METRO
MANILA TO BE KNOWN AS AGRIPINO MANALO NATIONAL
HIGH SCHOOL AND APPROPRIATING FUNDS THEREFOR

*Be it enacted by the Senate and House of Representatives of the Philippines in
Congress assembled:*

1 **SECTION 1. *Establishment of a National High School.*** – There shall be
2 established, under the supervision of the Department of Education, a national
3 high school in Barangay Aguho, Municipality of Pateros, Metro Manila to be
4 known as Agripino Manalo National High School.

5 **SEC. 2. *Appropriations.*** – The Secretary of Education shall
6 immediately include in the Department's program the operationalization of the
7 Agripino Manalo National High School, the funding of which shall be included
8 in the annual General Appropriations Act.

9 **SEC. 3. *Implementation.*** – The Secretary of Education shall issue rules
10 and regulations that may be necessary to carry out the purpose of this Act.

11 **SEC. 4. *Effectivity.*** – This Act shall take effect fifteen (15) days after
12 its publication in the *Official Gazette*.
