The Committees on Constitutional Amendments, Revision of Codes and Laws; and Local Government, to which were referred Senate Bill No. 1635, introduced by Senator Pangilinan, entitled:


have considered the same and have the honor to report these bills back to the Senate with the recommendation that the attached bill, Senate Bill No. 1757, prepared by the Committees, entitled:


