AN ACT ESTABLISHING A NATIONAL TECHNICAL VOCATIONAL HIGH SCHOOL IN BARANGAY TALISAY, CITY OF BALANGA, PROVINCE OF BATAAN TO BE KNOWN AS BALANGA CITY NATIONAL TECHNICAL VOCATIONAL HIGH SCHOOL AND APPROPRIATING FUNDS THEREFOR

Be it enacted by the Senate and House of Representatives of the Philippines in Congress assembled:

1 SECTION 1. Establishment of a National Technical Vocational High 2 School. – There is hereby established, under the supervision of the Department 3 of Education, a national technical vocational high school in Barangay Talisay, 4 City of Balanga, Province of Bataan to be known as Balanga City National 5 Technical Vocational High School. 6 SEC. 2. Appropriations. - The Secretary of Education 7 immediately include in the Department's program the operationalization of the 8 Balanga City National Technical Vocational High School, the funding of 9 which shall be included in the annual General Appropriations Act. 10 SEC. 3. Implementation. - The Secretary of Education shall issue rules 11 and regulations that may be necessary to carry out the purpose of this Act. 12 SEC. 4. Effectivity. - This Act shall take effect fifteen (15) days after 13 its publication in the Official Gazette.
