and Cua (J.), entitled:



AN ACT ESTABLISHING A NATIONAL TECHNICAL VOCATIONAL
HIGH SCHOOL IN BARANGAY TALISAY, CITY OF BALANGA,
PROVINCE OF BATAAN TO BE KNOWN AS BALANGA CITY
NATIONAL TECHNICAL VOCATIONAL HIGH SCHOOL AND
APPROPRIATING FUNDS THEREFOR

*Be it enacted by the Senate and House of Representatives of the Philippines in
Congress assembled:*

1 SECTION 1. *Establishment of a National Technical Vocational High*
2 *School.* -- There is hereby established, under the supervision of the Department
3 of Education, a national technical vocational high school in Barangay Talisay,
4 City of Balanga, Province of Bataan to be known as Balanga City National
5 Technical Vocational High School.

6 SEC. 2. *Appropriations.* -- The Secretary of Education shall
7 immediately include in the Department's program the operationalization of the
8 Balanga City National Technical Vocational High School, the funding of
9 which shall be included in the annual General Appropriations Act.

10 SEC. 3. *Implementation.* -- The Secretary of Education shall issue rules
11 and regulations that may be necessary to carry out the purpose of this Act.

12 SEC. 4. *Effectivity.* -- This Act shall take effect fifteen (15) days after
13 its publication in the *Official Gazette*.
