Recommending its approval with amendments

Mr. President:

The Committees on Youth, Women, and Family Relations and Constitutional Amendments, Revision of Codes and Laws to which were referred Senate Bill No. 2084, introduced by Senator Cayetano P., entitled:

**“AN ACT
AMENDING EXECUTIVE ORDER NO. 209, OTHERWISE KNOWN AS
THE FAMILY CODE OF THE PHILIPPINES AND FOR OTHER
PURPOSES”**


have considered the same and have the honor to report it back to the Senate with the recommendation that it be approved with the following amendments:


1. On page 1, lines 1 and 2, after the phrase “ARTICLE 7 OF”, insert the phrase “EXECUTIVE ORDER NO. 209, OTHERWISE KNOWN AS” and delete the phrase “TO READ” after the word “AMENDED”;
2. On the same page, Article 7 subparagraph 4, line 18, delete the conjunction “OR” after the semicolon (;);
3. On Article 7 subparagraph 5, line 20, insert the conjunction “OR” after the semicolon;

4. On the same page, Article 7 subparagraph 6, lines 21 and 22, insert a new subparagraph to read as “(6) ANY PROVINCIAL GOVERNOR OR MAYOR WITHIN HIS/HER JURISDICTION;
5. On page 2, Article 8, line 3, transfer the conjunction “OR” before the word “PROVINCIAL” after the noun “GOVERNOR”, and insert the noun “MAYOR” so that it shall now read as “PROVINCIAL GOVERNOR OR MAYOR”.
6. On the title page, after the verb “AMENDING”, insert the phrase “ARTICLE 7 OF”; “AS AMENDED and a comma (,)” before the word “OTHERWISE”; and delete the phrase “AND FOR OTHER PURPOSES” so that it shall now read as “AN ACT AMENDING ARTICLE 7 OF EXECUTIVE ORDER NO. 209, AS AMENDED, OTHERWISE KNOWN AS THE FAMILY CODE OF THE PHILIPPINES”.
