

The Committees on Justice and Human Rights and Finance, to which was referred S. No. 3015, introduced by Sen. Escudero, entitled:



APPROPRIATING FUNDS THEREFOR.”**


have considered the same and have the honor to report it back to the Senate with the recommendation that it be approved with the following amendment:
