#### **EXPLANATORY NOTE**

Section 235 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991 authorizes the collection of a special levy on real property, the proceeds of which shall exclusively accrue to the Special Education Fund (SEF) of local government units. Section 100 of the same law lists only three programs and projects to be prioritized by the local school board for funding from the SEF. These priorities do not include benefits to teachers and other personnel.

This bill seeks to amend Section 100 so that the list of projects to be prioritized by the Local School Board shall include

- a) Salaries and benefits of teachers and administrators or non-teaching personnel hired by the school board;
- b) Honorarium and allowances given to teachers and other school personnel, whether national or locally paid, given in additions to their salaries for additional services rendered or as additional benefits or incentives:
- c) Purchase of books and other reading materials, science and laboratory equipment and other equipment as may be determined by the school board as needed by the school; and
- d) Financial assistance to duly registered teachers cooperatives.

Human resources are the most important factor input in education. Hence benefits to personnel should be among the top priorities of the Special Education Fund.

In view of the foregoing, early passage of this bill is earnestly requested.

### **AN ACT**

STRENGTHENING FURTHER THE LOCAL SCHOOL BOARDS, AMENDING SECTION 100 OF REPUBLIC ACT NUMBER 7160, OTHERWISE KNOWN AS THE LOCAL GOVERNMENT CODE OF 1991 AND FOR OTHER PURPOSES

Be it enacted by the Senate and the House of Representatives of the Republic of the Philippines in Congress assembled:

1	SECTION 1. Section 100 of Republic Act. No. 7160, otherwise known
2	as the Local Government of 1991, is hereby amended as follows:

13	SEC. 3. Separability Clause If any provision of this act should be held
14	unconstitutional or invalid, other parts of provisions thereof not affected thereby
15	shall continue to be in full force and effect.
16	SEC. 4. Effectivity Clause This Act shall take effect fifteen (15) days
17	following its publication in at least two newspapers of general circulation.
