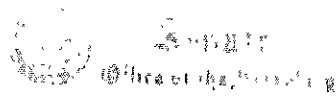


have considered the same and have the honor to report them back to the Senate with the recommendation that the attached S. No. 3101, entitled:
