



EXPLANATORY NOTE

This bill seeks to declare the La Mesa Watershed in the Cities of Quezon and Caloocan in the Municipality of Rodriguez, Province of Rizal as a Watershed Reservation.

With a total area 2,700 hectares, the La Mesa Watershed Reservation is the last remaining forest of its size in Metro Manila. Covering 700 hectares of the Watershed Reservation is a man-made lake, built to serve as water reservoir. The La Mesa Watershed Reservation is the primary source of potable drinking water for 12 M residents in the Metro Manila area. Also, the La Mesa Watershed Reservation serves as a wildlife sanctuary to many indigenous species of plants, trees, and animals. Thereby, the protection of La Mesa Watershed is deemed to be very crucial for the reason that it is the last remaining forest in Metro Manila and a critical water reservoir of a majority of Metro Manila residents.

This bill, therefore, seeks to declare the La Mesa Watershed as a Watershed Reservation in order to protect it from indiscriminate exploitation and to be able to maintain its ecological balance and preserve its source of water supply.

It is deemed crucial that we act on these now to ensure that our children and the succeeding generations will inherit a living earth with all of its bountiful natural resources and vibrant wildlife.

In view of the foregoing, the passage of this measure is earnestly urged.

AN ACT

ESTABLISHING THE LA MESA WATERSHED IN THE CITIES OF QUEZON AND CALOOCAN AND IN THE MUNICIPALITY OF RODRIGUEZ, PROVINCE OF RIZAL AS A WATERSHED RESERVATION AND FOR OTHER PURPOSES

Be it enacted by the Senate and House of Representatives of the Philippines in Congress assembled:

1 **SECTION.1. Title.** – This Act shall be known as the "La Mesa Watershed
2 Reservation Act of 2013."

3 **SEC.2. Land Classification.** – All lands comprising the La Mesa Watershed
4 Reservation shall fall under the classification of Watershed Reservation as provided for
5 in the Philippine Constitution.

6 **SEC.3. Scope and Coverage.** The La Mesa Watershed Reservation is hereby
7 declared into one Watershed Reservation covering parcels of land situated in the Cities
8 of Quezon and Caloocan and in the Municipality of Rodriguez, Province of Rizal, more
9 particularly described as follows:

10 Beginning at a point marked "1" on the map which is adjacent to the Eastern
11 Side of North Fairview Subdivision, and identical to corner "1" of Relocation Plan for

19 The technical descriptions provided in this Act will be subject to actual ground
 20 survey and verification to be conducted by the DENR within ninety (90) days after the
 21 effectivity of this Act. Any modification of the coverage of this Act due to such factors as
 22 changing ecological situations, new scientific or archeological findings, or discovery of
 23 traditional boundaries not previously taken into account shall be made through an act of
 24 Congress, after consultation with the affected public and concerned government
 25 agencies.

26 **SEC.4. Management of La Mesa Watershed Reservation.-** The La Mesa
 27 Watershed Reservation shall be under the joint administrative jurisdiction, supervision
 28 and control of the Department of Natural Resources (DENR) and Metropolitan
 29 Waterworks and Sewerage System (MWSS) and shall be managed in accordance with
 30 sustainable development, without impairing its usefulness as source of water for
 31 domestic use and other related purposes.

32 **SEC.5. Multi-Sectoral Watershed Management Council.-** The DENR in
 33 collaboration with the MWSS, shall create a Multi-Sectoral Watershed Management
 34 Council to act as oversight and policy making body over the watershed in accordance
 35 with existing laws, rules and regulations.

36 The Management Council shall prepare an integrated watershed management
 37 and development plan to include among others, intensive restoration and rehabilitation,
 38 water quality monitoring and delineation of buffer zone.

1 **SEC.6. Appropriations.** – The Secretary of the DENR shall immediately include
2 in the Department's program the implementation of this Act, the funding of which shall
3 be included in the annual General Appropriations Act.

4 **SEC.7. Reporting Responsibility.** – The Multi-Sectoral Watershed Management
5 Council shall submit an annual accomplishment report to the Secretary of the DENR on
6 the activities undertaken in the La Mesa Watershed Reservation.

7 **SEC.8. Construction and Suppletory Application of Existing Laws.** - The
8 provisions of this Act shall be construed liberally in favor of achieving environmental
9 protection and sustainable development. Provisions of Presidential Decree 1067,
10 otherwise known as the Water Code of the Philippines, Presidential Decree 705
11 otherwise known as Revised Forestry Code and existing forestry laws, and their
12 corresponding rules and regulations not inconsistent hereto shall have the suppletory
13 effect in the implementation of this Act.

14 **SEC.9. Separability Clause.** – If, for any reason, any part or section of this Act is
15 declared unconstitutional or invalid, such other parts not affected thereby shall remain
16 in full force and effect.

17 **SEC.10. Repealing Clause.** –All laws, decrees, proclamations, rules and
18 regulations inconsistent with the provisions of this Act are hereby repealed or modified
19 accordingly.

20 **SEC.11. Effectivity Clause.** This Act shall take effect fifteen (15) days after its
21 complete publication in the *Official Gazette* or in a national newspaper of general
22 circulation available in the La Mesa Watershed Reservation.
