Re: Senate Bill no. 480

Recommending its approval with amendments

Sponsors: Senator Antonio F. Trillanes IV

MR. PRESIDENT:

The Committees on National Defense and Security and Finance, to which was referred Senate Bill No. 480, introduced by Senator Antonio F. Trillanes IV and Senator Sonny Angara, entitled:

**“AN ACT
INCREASING THE QUARTERS ALLOWANCE OF OFFICERS AND
ENLISTED PERSONNEL OF THE ARMED FORCES OF THE PHILIPPINES
AND FOR OTHER PURPOSES**

has considered the same and has the honor to report it back to the Senate with the recommendation that it be approved with the following amendments:

1. On page 2, Sec. 4., line 21, before the first article “The” insert the words “TO FINANCE”;
2. On the same page, section, and line; replace capital “T” with a small letter “t” in the first article “The”;

3. On the same page, section, and line; after the word "Act" insert a punctuation comma "," ;
4. On the same page and section, from lines 21 to 23, delete the entire phrase between the word "ACT" and period "."; and in lieu, insert the following paragraph:

THE FUNDS TO BE ALLOCATED SHALL BE CHARGED AGAINST THE FOLLOWING SOURCES:

- 1.) **FIFTY PERCENT (50%) OF THE NET GOVERNMENT SHARE IN THE PROCEEDS OF SERVICE CONTRACT NO. 38 AUTHORIZED UNDER SEC. 8 OF P.D. 910 (MALAMPAYA FUNDS);**
- 2.) **TWENTY PERCENT (20%) OF THE ANNUAL SHARE OF THE AFP MODERNIZATION PROGRAM ON THE INCOME DERIVED FROM THE LEASES, JOINT VENTURES AND OTHER SIMILAR TRANSACTIONS ON PROPERTIES IN METRO MANILA ENTERED INTO BY THE BCDA AS MANDATED UNDER EO 309;**
- 3.) **ANNUAL SAVING OF THE DEPARTMENT OF NATIONAL DEFENSE AND THE ARMED FORCES OF THE PHILIPPINES; AND**
- 4.) **THE MISCELLANEOUS PERSONNEL BENEFITS FUNDS**


SUCH AMOUNT AS MAY BE NECESSARY TO FUND THE QUARTERS ALLOWANCE UNDER THIS ACT IS HEREBY AUTHORIZED TO BE AUTOMATICALLY SET ASIDE FROM THE SAID FUND SOURCES FOR THIS PURPOSE. ANY DEFICIENCY IN THE FINANCIAL REQUIREMENT SHALL BE COVERED BY THE ANNUAL APPROPRIATIONS PASSED BY CONGRESS. PROVIDED, HOWEVER, THAT FOR THE INITIAL YEAR OF IMPLEMENTATION OF THIS ACT, SUCH APPROPRIATION SHALL COMMENCE ON THE THIRD QUARTER OF THE FISCAL YEAR. ;

5. On page 3, line 1, Sec. 6., delete the word "All", and in lieu insert the following phrase:


PROVISIONS OF REPUBLIC ACT NO. 7227, AS AMENDED BY REPUBLIC ACT NO. 7917, EXECUTIVE ORDER 309 (s2000), PRESIDENTIAL DECREE NO. 910 AND ALL OTHER ; and

6. On the same page and section, line 2; after the word "or" replace the word "modifies" with the word "MODIFIED"
