Re: S. Jt. Res. No. 2

Recommending its approval with amendments, taking into consideration Senate Bill No. 1267

Sponsor: Senator Antonio F. Trillanes IV

**MR. PRESIDENT:**

The Committees on National Defense and Security; Public Order and Dangerous Drugs; and Finance, to which was referred Jt. Res. No. 2, introduced by Senator Antonio F. Trillanes IV and Senator Sonny Angara, entitled:

**“JOINT RESOLUTION INCREASING THE SUBSISTENCE ALLOWANCE OF ALL OFFICERS AND ENLISTED PERSONNEL OF THE ARMED FORCES OF THE PHILIPPINES (AFP) AND OF ALL COMMISSIONED AND NON-COMMISSIONED PERSONNEL OF THE PHILIPPINE NATIONAL POLICE FROM NINETY PESOS (P90.00) TO ONE HUNDRED AND FIFTY PESOS (P150.00) PER DAY”**

and taking into consideration Senate Bill No. 1267, introduced by Sen. Legarda, entitled:

**“AN ACT INCREASING THE COMBAT DUTY PAY AND SUBSISTENCE ALLOWANCE OF ALL PERSONNEL OF THE ARMED FORCES OF THE PHILIPPINES TO TWENTY FIVE PERCENT (25%) OF THEIR BASE PAY AND TO ONE HUNDRED EIGHTY PESOS (P180.00) PER DAY, RESPECTIVELY AND PROVIDING FUNDS THEREFOR”**


has considered the same and has the honor to report it back to the Senate with the recommendation that it be approved with the following amendments:

1. On page 1, the second whereas clause, line 7, after the acronym "(PNP)", insert a comma "," followed by the phrase **"BUREAU OF FIRE PROTECTION (BFP), BUREAU OF JAIL MANAGEMENT AND PENOLOGY (BJMP) AND PHILIPPINE NATIONAL POLICE ACADEMY (PNPA) CADETS"** ;
2. On the same page, third whereas clause, line 9, delete the word "police" and in lieu replace it with the words **"THE UNIFORMED"** ;
3. On the same whereas clause, line 10, after the word "personnel", insert the phrase **"OF THE DILG"**;
4. On the same page, fourth whereas clause, line 12, after the word "officers" delete the conjunction **"and"** in lieu replace it with a comma "," ;
5. On the same whereas clause, from lines 12-13, between the words "enlisted personnel" and preposition "of", insert a comma "," followed by the phrase **"CANDIDATE SOLDIERS, PROBATIONARY SECOND LIEUTENANTS, CADETS AND CIVILIAN ACTIVE AUXILIARIES (CAA)"** ;
6. Still on the same whereas clause, line 13, after the acronym "PNP", insert a comma "," followed by the acronyms: **"BFP, BJMP AND PNPA CADETS"** ;
7. On page 2, seventh whereas clause, line 2, after the words "Philippine National Police" insert a comma "," preceded by the phrase **"BUREAU OF FIRE PROTECTION, BUREAU OF JAIL MANAGEMENT AND PENOLOGY AND PHILIPPINE NATIONAL POLICE ACADEMY CADETS"** ;
8. On the same whereas clause, line 5, before the word "personnel" delete the word "police" and in lieu, insert the words **"THE UNIFORMED"** ;

9. Still on the same whereas clause and line, after the word "personnel", insert the phrase, **"OF THE DILG"** ;
10. On the resolatory clause, line 9, before the word "enlisted", delete the conjunction "and", and in lieu, replace it with a **comma ( , )** ;
11. On the same resolatory clause and line, after the word **"personnel"** insert a **"comma (,)"** followed by the phrase **"CANDIDATE SOLDIERS, PROBATIONARY SECOND LIEUTENANTS, CADETS AND CIVILIAN ACTIVE AUXILIARIES"** ;
12. Still on the same resolatory clause, line 10, after the acronym **"(PNP)"** insert a **comma ","** proceeded by the phrase **"BUREAU OF FIRE PROTECTION (BFP), BUREAU OF JAIL MANAGEMENT AND PENOLOGY (BJMP) AND PHILIPPINE NATIONAL POLICE ACADEMY (PNPA) CADETS"** ;
13. Still on the same resolatory clause, line 11, between the word **"day"** and **"period (.)"** insert the phrase **"EFFECTIVE JULY 1, 2014"** ;
14. On the second resolatory clause, line 15, after the acronym **"(PNP)"** insert a **comma ","** proceeded by the phrase **"BUREAU OF FIRE PROTECTION (BFP), BUREAU OF JAIL MANAGEMENT AND PENOLOGY (BJMP) AND PHILIPPINE NATIONAL POLICE ACADEMY (PNPA) CADETS"** ;
15. Still on the same **second resolatory clause, line 19, after the word "year"** insert the phrase **"AND/OR THE MISCELLANEOUS PERSONNEL BENEFITS FUND"** ;
16. Still on the same second resolatory clause, line 20, delete the words **"increase in"** ; and
17. Finally, the new title of Jt. Res. no. 2 as amended, shall now read as follows:

**“JOINT RESOLUTION INCREASING THE SUBSISTENCE ALLOWANCE OF ALL OFFICERS, ENLISTED PERSONNEL, CANDIDATE SOLDIERS, PROBATIONARY SECOND LIEUTENANTS, CADETS AND CIVILIAN ACTIVE AUXILIARIES (CAA) OF THE ARMED FORCES OF THE PHILIPPINES (AFP) AND OF ALL COMMISSIONED AND NON-COMMISSIONED PERSONNEL OF THE PHILIPPINE NATIONAL POLICE, BUREAU OF FIRE PROTECTION (BFP), BUREAU OF JAIL MANAGEMENT AND PENOLOGY (BJMP) AND PHILIPPINE NATIONAL POLICE ACADEMY (PNPA) CADETS FROM NINETY PESOS (P90.00) TO ONE HUNDRED AND FIFTY (P150.00) PER DAY EFFECTIVE JULY 1, 2014”.**


