EXPLANATORY NOTE

Article XIII Section 1 of the 1987 Philippine Constitution provides, to wit:

"Section 1. The Congress shall give highest priority to the enactment of measures that protect and enhance the right of all the people to human dignity, reduce social, economic, and political inequalities, and remove cultural inequities by equitably diffusing wealth and political power for the common good.

To this end, the State shall regulate the acquisition, ownership, use, and disposition of property and its increments."

In furtherance of the aforequoted provision coupled with the enactment of this bill into law, will result in enhancing the rights of informal settlers by providing an additional safeguard that would ensure that the basic services they are entitled to under Republic Act 7279, otherwise known as the Urban Development and Housing Act of 1992, are properly implemented and sufficiently funded.

In view of the foregoing, the approval of this bill is earnestly recommended.

Be it enacted by the Senate and House of Representatives of the Philippines in Congress assembled:

SECTION 1. Section 21 of Republic Act No. 7279 is hereby amended to read as follows:

SECTION. 21-A MEMORANDUM OF AGREEMENT. - IN CASE THE SOCIALIZED HOUSING OR RESETTLEMENT AREA IS LOCATED LOCAL GOVERNMENT ANOTHER UNIT, THE GOVERNMENT UNIT WHICH IMPLEMENTED THE SOCIALIZED **HOUSING** OR RESETTLEMENT SHALL, THROUGH MEMORANDUM OF AGREEMENT, MAKE AVAILABLE TO THE HOST LOCAL GOVERNMENT UNIT WHERE THE SOCIALIZED HOUSING OR RESETTLEMENT WILL BE LOCATED ALLOCATION FOR THE PROVISIONS OF SUCH OTHER BASIC MENTIONED IN THE **SERVICES** AND FACILITIES PARAGRAPH OF SECTION 21 HEREOF.

IN ADDITION TO THE SOURCES OF FUNDS PROVIDED UNDER SECTION 42 OF THIS ACT, THE ALLOCATION FOR THE BASIC SERVICES AND FACILITIES MAY BE TAKEN BY THE LOCAL GOVERNMENT UNIT IMPLEMENTING THE SOCIALIZED HOUSING OR RESETTLEMENT FROM THE TWENTY PERCENT (20%) OF THE INTERNAL REVENUE ALLOTMENT APPROPRIATED FOR DEVELOPMENT PROJECTS AS MANDATED UNDER SECTION 287 OF REPUBLIC ACT NO. 7160, OTHERWISE KNOWN AS THE LOCAL GOVERNMENT CODE."

SECTION 2. Implementing Rules and Regulations. Within sixty days after the effectivity of this Act, the Secretary of the Interior and Local Government shall, in coordination with the

Housing and Urban Development Coordinating Council, issue the corresponding rules and regulations necessary for the effective implementation of this Act.

SECTION 3. Repealing Clause. All laws, executive orders, proclamations, rules, regulations and other issuances or parts thereof which are inconsistent with the provisions of this act are hereby repealed, amended or modified accordingly.

SECTION 4. Effectivity Clause. This Act shall take effect fifteen (15) days after its complete publication in at least two (2) national newspapers of general circulation.
