Upon motion of Senator Cayetano (A), there being no objection, the Body considered Proposed Senate Resolution No. 283, entitled

**RESOLUTION COMMENDING THE** 

ARMED FORCES OF THE PHILIP-PINES AND THE PHILIPPINE NATIONAL POLICE FOR THE HEROIC PERFORMANCE OF THEIR SWORN CONSTITUTIONAL DUTY AS PROTECTORS OF THE PEOPLE AND THE STATE, AND AS SENTI-NELS OF PEACE AND ORDER IN THE ZAMBOANGA CRISIS.

The Deputy Secretary for Legislation, Atty. Edwin B. Bellen, read the text of the resolution, to wit:

WHEREAS, the Armed Forces of the Philippines is the protector of the people and the State. Its goal is to secure the sovereignty of the State and the integrity of the national territory;

WHEREAS, the Philippine National Police is responsible for maintaining peace and order, and taking all necessary steps to ensure public safety;

WHEREAS, on 09 September 2013, a crisis erupted in Zamboanga City where a faction of the Moro National Liberation Front, reportedly led by Nur Misuari, attempted to raise the flag of the self-proclaimed Bangsamoro Republic at the Zamboanga City Hall, which on 12 August 2013 had declared its independence in Talipao, Sulu:

WHEREAS, this apparent armed incursion resulted into a crisis prompting the Armed Forces of the Philippines (AFP) and the Philippine National Police (PNP) to face it squarely with the primary objective of freeing the hostages and expelling the MNLF from Zamboanga City;

WHEREAS, sensing that the standoff had degenerated into an urban warfare, placing the entire Zamboanga City into a standstill for days, the AFP and the PNP, especially those military and police personnel deployed in the forefronts, battled the MNLF with bravery and gallantry without any reservations despite the imminent loss of life and limb, leading to the freeing of 194 hostages, the death and capture of at least 100 and 223 MNLF fighters, respectively, and the surrender of 52 MNLF combatants;

WHEREAS, on 28 September 2013, the Philippine government declared the end of military operations in Zamboanga City albeit the AFP and the PNP still continue with their designated tour of duty to run after the remaining combatants of the MNLF faction and to maintain the gains of peace and order that they have accomplished;

WHEREAS, such display of dedication and commitment to subdue the enemies of the State

and to restore peace and order shown by the AFP and the PNP cannot be overstated; it is an accomplishment characterized by the performance of a sworn duty not by its mere utterance or through press statement but by standing by it in an actual battle for country and people; verily these elements of the AFP and the PNP, the soldiers and the policemen in the Zamboanga crisis, deserve the Senate's commendation;

NOW, THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED, To COMMEND the Armed Forces of the Philippines and the Philippine National Police for the heroic performance of their sworn constitutional duty as protectors of the people and the State and as sentinels of peace and order in the Zamboanga crisis.

*RESOLVED, FURTHER*, That a copy of this Resolution be given to the concerned officers and men of the AFP and the PNP, and to the bereaved families of those who fought and died in resolving the Zamboanga crisis.

#### ADOPTION OF PROPOSED SENATE RESOLUTION NO. 283

At the instance of Senator Cayetano (A), all members who were present in the hall were made coauthors of Proposed Senate Resolution No. 283.

#### MANIFESTATION OF SENATOR CAYETANO (A)

Senator Cayetano (A) stated that there have been so many inquiries directed to the Senate about the P140-billion rehabilitation fund in the GAA for 2014, and that, in fact, last Monday, five mayors from Eastern Samar also asked about the funding and how the funds shall be utilized. These questions, he said, will be addressed in the hearing of the Congressional Oversight Committee on the Philippine Disaster Risk Reduction and Management Act of 2010, chaired by Senator Trillanes, which will be held the following day at one o'clock in the afternoon.

#### **PROPOSED SENATE RESOLUTION NO. 427**

Upon motion of Senator Cayetano (A), there being no objection, the Body considered Proposed

Senate Resolution No. 427, entitled

RESOLUTION EXPRESSING THE GRATITUDE TO THE MEMBERS OF THE INTERNATIONAL COMMUNITY FOR THEIR HUMANITARIAN RESPONSE IN THE AFTERMATH OF TYPHOON YOLANDA.

Atty. Regina Evangelista read the text of the resolution, to wit:

WHEREAS, super typhoon Yolanda (International name: Haiyan) entered the Philippine Area of Responsibility on November 6, 2013;

WHEREAS, with maximum sustained winds of 235 kph and gustiness of up to 275 kph, and a classification as a Category 5 typhoon, Yolanda was the most powerful tropical cyclone ever recorded;

WHEREAS, the extraordinary strength and the speed of Yolanda caused a storm surge to rise in coastal areas, creating waves reported to be as high as five meters, and wiping out buildings, homes and entire island communities;

WHEREAS, the affected population is reportedly at 2,146,418, with the total death toll at 6,069, another 25,559 injured and 1,613 missing;

WHEREAS, the total estimated damages caused by Yolanda has reached a staggering Php24 billion pesos;

WHEREAS, in the immediate aftermath of Yolanda, the typhoon-stricken areas received much-needed aid in the form of provisions for relief supplies, transport and logistical assistance and medical services from other countries particularly the nations of Algeria, Australia, Austria, Bahrain, Bangladesh, Belgium, Botswana, Brazil, Brunei Darussalam, Cambodia, Canada, China, Czech Republic, Denmark, Finland, France, Germany, Hungary, India, Indonesia, Iraq, Ireland, Israel, Italy, Japan, Kuwait, Laos, Luxembourg, Macau Special Administrative Region, Malaysia, Marshall Islands, Mexico, Myanmar, Netherlands, New Zealand, Norway, Pakistan, Panama, Papua New Guinea, Qatar, Romania, Russia, Saudi Arabia, Singapore, Slovakia, South Africa, South Korea, Spain, Sri Lanka, Sweden, Switzerland, Taiwan, Thailand, Turkey, Ukraine, United Arab Emirates, United States of America, United Kingdom, Vatican, Vietnam; and international organizations, namely: the Arab Gulf Fund for UN

Development, Asian Development Bank (ADB), European Union (EU), International Committee of the Red Cross (ICRC) and the International Federation of Red Cross and Red Crescent Societies (IFRC), Organization of Islamic Cooperation (OIC), United Nations Children's Fund (UNICEF), UN Office for the Coordination of Humanitarian Affairs (UN OCHA), and the World Food Programme (WFP);

WHEREAS, the total foreign medical personnel that arrived and provided treatment to the wounded and the sick has reached 1,201;

WHEREAS, 15 Member States of the UN have military assets operating and more than 25 foreign military aircraft from 11 different Member States are delivering relief items in the typhoon-stricken areas;

WHEREAS, UN OCHA has declared funding amounting to US\$404 million for the Philippines for typhoon Haiyan as of November 2013, according to the Financial Tracking Service (FTS);

WHEREAS, \$167 million has been contributed for the Typhoon Haiyan Action Plan by over 80 entities including Member States, the Central Emergency Response Fund, multilateral institutions, and private persons;

WHEREAS, the support of other countries, international organizations and our other partners from around the world, who have stood side-by-side with us in this moment of great challenge for millions of Filipinos, is worth commending as a source of inspiration as the country strives to rise from the massive loss of lives and property;

NOW, THEREFORE, BE IT RESOLVED, to express gratitude to the members of the international community for their humanitarian response in the aftermath of super Typhoon Yolanda.

*RESOLVED FURTHER*, that a copy of this Resolution be furnished to the embassies/consular offices of the countries and headquarters of the organizations mentioned above.

#### INQUIRY OF SENATOR SOTTO

Senator Sotto asked whether the figures and data mentioned in the "whereas" clauses of the resolution were accurate, for instance, with regard to the total amount of monetary donations. Senator Cayetano (A) explained that the resolution would be adopted subject to style to allow for the checking and validation of the data presented in the "whereas" clauses, such as the names of the countries and their donations and the number of casualties of the calamity. He assumed that the data that were received by the Senate on December 18, 2013 were correct as of the writing of the resolution, but he nevertheless suggested that an update of the data could be asked from Rehabilitation Czar Sec. Panfilo Lacson and DILG Sec. Mar Roxas.

The Senate President stated that the crux of the resolution was to express gratitude to the members of the international community who helped the country. The Senate President nonetheless agreed with Senator Sotto that the resolution should contain accurate facts especially on the amounts of donations involved.

Senator Cayetano (A) agreed to Senator Sotto's suggestion to replace the figures with descriptive words to reflect the extent of the devastation and amount of help received.
