CALL TO ORDER

At 3:23 p.m., the Senate President, Hon. Franklin M. Drilon, called the session to order.

PRAYER

Sen. Juan Ponce Enrile led the prayer, to wit:

ROLL CALL

QUESTION OF PRIVILEGE OF SENATOR GUINGONA

Rising on a question of personal and collective privilege, Senator Guingona delivered the following speech:

THE SEARCH FOR TRUTH

I begin with a quote from a once-famous 19th century French essayist by the name of

M

Joseph Joubert. This prolific writer wrote, and I quote:

"When you go in search of honey ... you must expect to be stung by bees."

When I was given the task of serving as chair of the Senate Blue Ribbon Committee, I knew it would be a difficult one - an extremely difficult one.

It is a difficult task because its mandate is the search for truth, and, in the process, pinpoint accountabilities. Searching for truth, one might say, is like searching for honey.

Hindi po madali ang tungkulin at layunin ng Senate Blue Ribbon Committee at ng chairman nito. Subali't mahalaga ang kanyang layunin at tungkulin. Dahil dito, tinanggap ko ang tungkulin. At sa abot ng aking makakaya, sinisikap kong gawin ito nang maayos at mahusay.

Isang malaking hamon ang paghahanap ng katotohanan – lalo na kapag ang sangkot ay ang interes ng sambayanan.

Sa tungkuling ito, hindi umaasa ang komite ng papuri o paghanga man. Sapat na po ang masabi natin na nagawa natin nang tama ang ating tungkulin.

The work and mission of the Senate Blue Ribbon Committee has become even more difficult because the probe allegedly involves three of our peers in the Senate. I am not sure if this has a precedent in the history of Congress of our Republic. I am inclined to believe, at this point, that there is none.

Natatandaan ko po na nang umpisahan ng Blue Ribbon Committee ang imbestigasyon sa isyu ng PDAF, malaki ang naging pagdududa sa isip ng ating mga kababayan.

Una, iimbestigahan daw ba ng Senado ang sariling mga miyembro nito?

Pangalawa, kaya raw ba ng Senado ng Pilipinas na magsagawa ng isang tunay, patas at masusing imbestigasyon kung ang mga sangkot sa usapin ay mga kapwa senador?

Sa kabila ng mga pagdududang ito, tinitiyak ko po sa inyo na sinikap pa rin ng Blue Ribbon Committee na isagawa nang maayos ang tungkuling ito.

At ngayon po, nakalulungkot na sa puntong ito ang pagdududa sa kakayahan natin ay manggagaling mismo sa kasamahan natin. Hindi po dapat na mangyari ito.

Allow me, therefore, to clear the air.

For the record, I have no intention of prejudging the guilt or innocence of any of our peers allegedly involved in the issue now under probe by the Senate Blue Ribbon Committee.

The transcripts of the hearings should prove this fact. And I believe I speak for myself as well as for our peers who have attended the hearings when I say that we have done our utmost best to ensure that the dignity and honor of our colleagues involved in this issue are preserved and protected.

I am aware, however, that a recent statement I have made both at the last committee hearing and press conference has caused offense and the perception that I may have "prejudged" the guilt of one of our peers.

Let me assure you as well as our colleagues that to "prejudge" has never been my intention.

I understand that the offense and the perception were apparently the result of the use of an analogy from the favorite national pastime – basketball. True, I have made such reference.

Let me assure you and our colleagues that the phrase did not refer to a state of guilt on the part of any person. *Uulitin ko*, the phrase did not refer to a state of guilt on the part of any person.

There are questions the Committee is attempting to answer. The witness had surely helped in the search for the answers — I repeat, in the search for answers not in the determination of guilt or innocence.

The phrase was used by me to describe and underscore the possible impact and value of the testimony of a witness.

I believe that there is a battle we must all fight together as one. And this is the battle to restore our people's trust in the Senate of the Republic of the Philippines.

Naniniwala po ako, mayroon tayong isang malaking laban na kailangang harapin – at harapin natin ng sama-sama. Ito ay ang pakikipaglaban para maibalik ang tiwala ng mga kababayan natin sa Senado.

Kasama dito ang tapat at magaling na pagtupad ng tungkulin ng Blue Ribbon Committee.

Part of that effort is the dedicated and good performance of its job by the Blue Ribbon Committee.

Mahirap ang tungkuling ginagampanan ng Blue Ribbon Committee. Pero anumang hirap nito, ito ay gagampanan natin.

Ano pa man ang hirap ng tungkuling ito, maaasahan ninyo na "trabaho lang po...at walang personalan."

SUSPENSION OF SESSION

Upon motion of Senator Aquino, the session was suspended.

It was 3:41 p.m.

RESUMPTION OF SESSION

At 3:42 p.m., the session was resumed.

INTERPELLATION OF SENATOR SOTTO

Senator Sotto said that while he concurred with the intention of the Blue Ribbon Committee to arrive at the truth, he found it difficult to reconcile the fact that the committee conducts two investigations at the same time: (1) investigation of public accountability; and 2) investigation of fellow senators. He believed that the latter could be best handled by the Committee on Ethics and Privileges so that the Blue Ribbon Committee could focus on the public accountability hearings concerning the PDAF issue to come up with better legislation.

Senator Guingona agreed, saying that he has no objection to the proposal.

INTERPELLATION OF SENATOR ESTRADA

Preliminarily, Senator Estrada said that while he has been hurt by Senator Guingona's parting statement during the last hearing of the Blue Ribbon Committee on the issue of PDAF, he was joining Senator Guingona in his quest to find the truth. However, he asked Senator Guingona for his true intention behind the statement "I think the testimony of Tuason is a three-point shot na, buzzer-beater na, winning shot pa," particularly since he mentioned in his speech that the said remark was not meant to prejudge him (Senator Estrada). Senator Guingona explained that he had no intention of hurting Senator Estrada with the statement and said that it was an expression of his personal opinion on the value of the witness' testimony.

Asked how the statement, which in basketball parlance refers to a winning basket, can be connected to the testimony of Mrs. Tuason, Senator Guingona replied that the witness presented a very strong testimony since this was the first time that a witness claimed that she personally handed money to a senator.

Saying that he would not discuss details of the issue since the plenary session was not the proper forum, Senator Estrada nevertheless denied the allegations in the affidavit of Mrs. Tuason. He pointed out that Mrs. Tuason presented an empty affidavit because it contained generalizations and was bereft of details. He noted that the witness could not even remember how much money she allegedly delivered to him nor his address in Greenhills, San Juan.

Senator Guingona clarified that while he respected Senator Estrada's opinion, he nevertheless did not agree with it.

Senator Estrada said he respected Senator Guingona's opinion. However, he asked whether Senator Guingona took Mrs. Tuason's statement as gospel truth. Senator Guingona replied that he took the affidavit as a valuable testimony of a witness who said that she had personally given money to a senator.

On Senator Estrada's suggestion that he should have considered other pieces of evidence presented before coming to a conclusion on the matter, Senator Guingona reiterated that he did not make any conclusion but was merely expressing his opinion on the value of the testimony. He further disagreed with the observation that Mrs. Tuason's testimony was bereft of details because the witness even recalled having gone to the Senate parking lot and the experience of giving money to a senator many times in different places, and also remembered the faces of two staff members. He added that it would be difficult for the witness to remember the amount of money she delivered to the senator in 2008 which was six years ago. He doubted whether anyone could remember how much he spent in a single day for that long a period of time.

But Senator Estrada pointed out that the issue was whether the witness was telling the truth or not, and he asked how Senator Guingona could be certain that Mrs. Tuason was not lying. He recalled having mentioned during his own media interviews that Mrs. Tuason only brought trays of sandwiches to his office and not a duffel bag as she claimed, and that he even challenged the Office of the Sergeant-At-Arms to produce the CCTV footages showing the witness delivering money to him.

Moreover, Senator Estrada said that he was surprised that only Atty. Gigi Reyes and himself were mentioned in the affidavit of Mrs. Tuason even if she was visiting other senator-friends and was asking for funding for some projects through PDAF. He questioned why Senator Guingona did not ask the witness about the other senators she was visiting aside from Senator Enrile and himself. Senator Guingona replied that they did ask Mrs. Tuason but the witness denied it.

Asked by Senator Estrada why Senator Enrile and himself were the only legislators mentioned in Mrs. Tuason's testimony even if he has received information that the witness also visited incumbent and former senators for projects, Senator Guingona replied that such questions should be addressed to the witness herself.

Senator Estrada stated that Senator Guingona had prejudged him in this issue, but Senator Guingona maintained that this was not the case.

SUSPENSION OF SESSION

With the permission of the Body, the Chair suspended the session.

It was 3:54 p.m.

RESUMPTION OF SESSION

At 5:19 p.m., the session was resumed.

Thereupon, the Chair recognized Senator Estrada for the continuation of his interpellation.

MANIFESTATION OF SENATOR ESTRADA

Senator Estrada stated that during the break, Senate President Drilon requested him not to prolong the debate with Senator Guingona because the exchange might become personal. As befitting statesmen and honorable legislators, he said that he was acceding to the request of the Senate President. He likewise revealed that during the break, he had a lengthy talk with Senator Guingona where he expressed all his sentiments regarding the manner by which the Blue Ribbon Committee was handling the hearings on the pork barrel scam. He said that he requested Senator Guingona to hold impartial hearings and advised him to refrain from issuing statements that might influence the outcome of the investigation.

Senator Guingona said that the suggestions and advice of Senator Estrada were well-taken.

REFERRAL OF SPEECH TO COMMITTEE

Upon motion of Senator Cayetano (A), there being no objection, the Chair referred the speech of Senator Guingona and the interpellations thereon to the Committee on Rules.

SUSPENSION OF SESSION

Upon motion of Senator Cayetano (A), the session was suspended.

It was 5:22 p.m.

RESUMPTION OF SESSION

At 5:22 p.m., the session was resumed.

COMMITTEE REPORT NO. 2

ON SENATE BILL NO. 1733 (Continuation)

Upon motion of Senator Cayetano (A), there being no objection, the Body resumed consideration, on Second Reading, of Senate Bill No. 1733 (Committee Report No. 2), entitled

AN ACT IMPLEMENTING THE PEOPLE'S RIGHT TO INFORMATION AND THE CONSTITUTIONAL POLICIES OF FULL PUBLIC DISCLOSURE AND HONESTY IN THE PUBLIC SERVICE AND FOR OTHER PURPOSES.

Senator Cayetano (A) stated that the parliamentary status was still the period of committee amendments.

Thereupon, the Chair recognized Senator Poe, sponsor of the measure.

MANIFESTATION OF SENATOR POE

At the outset, Senator Poe informed the Body that she would be using the amended copy of the bill containing the approved committee amendments as of February 17, 2014 as the working draft.

COMMITTEE AMENDMENTS

As proposed by Senator Poe, there being no objection, the Body approved the following amendments, one after the other:

- On page 3, line 25, between the word "function" and the period (.), insert a comma (,) and the phrase THE REVELATION OF WHICH WOULD IMPAIR THE IMPARTI-ALITY OF VERDICTS OR OTHERWISE OBSTRUCT THE ADMINISTRATION OF JUSTICE;
- 2. On page 4, line 20, after the word "before," delete the phrase "the Ombudsman or";
- 3. On page 8, lines 35 and 36, after period (.) following the word "negligence," delete the sentence "The procedure for such petition shall be summary in nature" and in lieu thereof, insert the sentence SUBJECT TO THE PRO-VISIONS OF EXISTING LAWS AND THE ISSUANCES OF THE SUPREME COURT, ALL COURTS SHALL GIVE PREFERENCE TO THE HEARING AND DISPOSITION OF PETITIONS FOR MANDAMUS FILED PURSUANT TO THE PROVISIONS OF THIS ACT.;
- 4. On the same page, line 37, after the word "examine," replace the word "then" with THEM;
- On page 11, after the word "supervisor" on line 25, delete the words "the Ombudsman" up to line 26;
- 6. On the same page, between lines 29 and 30, insert a new subsection (a)(5) to read as follows:
 - (5) FAILURE TO UPLOAD INFORMATION REQUIRED TO BE POSTED ON AN AGENCY WEBSITE WITHIN THE PERIOD PROVIDED UNDER SECTION 19: *PROVIDED*, THAT THE HEAD OF AGENCY OR ANY OTHER OFFICER OR EMPLOYEE TASKED TO PERFORM SAID UPLOADING SHALL BE HELD LIABLE.
- 7. On the same page, line 47, after the word "any," delete the phrase "public officer or

employee" and in lieu thereof, insert the word INDIVIDUAL; and

- 8. On page 12, between lines 2 and 3, insert a new subsection (g) to read as follows:
 - (G) THE RESPONSIBLE OFFICERS OF THE PUBLIC SERVICE CONTRACTOR AND THE SIGNATORIES TO THE CONTRACT OR ANY DOCUMENT EVIDENCING TRANSACTION WITH THE GOVERN-MENTOR GOVERNMENT AGENCY WHO FAIL TO SUBMIT THE NECESSARY DOCUMENTS/PAPERS AS PROVIDED IN SECTION 4 OF THIS ACT.

TERMINATION OF THE PERIOD OF COMMITTEE AMENDMENTS

There being no other committee amendment, upon motion of Senator Cayetano (A), there being no objection, the Body closed the period of committee amendments.

REQUEST FOR CLEAN COPY

Senator Cayetano (A) asked that the Members be furnished with a clean copy of the bill.

SUSPENSION OF CONSIDERATION OF SENATE BILL NO. 1733

Upon motion of Senator Cayetano (A), there being no objection, the Body suspended consideration of the bill.

MANIFESTATION OF SENATOR POE

Senator Poe expressed gratitude to the Members for the support and assistance extended to her in drafting the bill. In particular, she expressed gratitude to Senator Sotto for helping her in the previous day's session when she presented the amendments for the first time, and to Senate President Drilon for his patience and for guiding her during the process.

ACKNOWLEDGMENT OF THE PRESENCE OF GUESTS

At this juncture, Senator Cayetano (A) acknowledged the presence in the gallery of the barangay captains of Bislig City, Surigao Del Sur, headed by City Mayor Librado Navarro.

Senate President Drilon welcomed the guests to the Senate.

NEXT DAY'S AGENDA

Senator Cayetano (A) stated that in the next day's session, the Body would resume consideration on Senate Bill No. 2046 (*Go Negosyo* bill). He requested the Members to prepare their individual amendments that would immediately follow the committee amendments.

ADJOURNMENT OF SESSION

Upon motion of Senator Cayetano (A), there being no objection, the Chair declared the session

adjourned until three o'clock in the afternoon of the following day.
