AN ACT MANDATING THE USE OF RECYCLABLE OR BIODEGRADABLE MATERIALS FOR THE PACKAGING OF CONSUMER PRODUCTS

Be it enacted by the Senate and the House of Representatives of the Philippines in Congress assembled:

SECTION 1. **Declaration of Policy**. The State hereby declares as policy the conservation and preservation of nature. In this respect, the use of recyclable and biodegradable materials is mandated in the manufacturing process of consumer goods.

SECTION 2. **Definition of terms.** As used in this Act, the following terms shall be construed as follows:

- a) Recyclable shall mean the quality of a material which makes it useful to be used again in any manufacturing process.
- b) Biodegradable shall mean the quality of being organically assimilated in the natural setting.
- c) Consumer goods shall refer to items for sale manufactured in high-volume for a mass market.

SECTION 3. **Tax Incentive.** Any business or non-business entity which shall undertake the effort of using recyclable and biodegradable materials for the packaging of consumer goods shall enjoy a tax deductibility privilege on its income tax to the extent of the proven cost of the recyclable or biodegradable material on its production process.

SECTION 3. Implementing Agencies Rules and Regulations. The necessary rules and regulations to effectively carry out the purposes of this Act shall be promulgated by the Secretary of the Department of Environment and Natural Resources within sixty (60) days after the effectivity of this Act.

SECTION 4. **Repealing Clause.** All laws, decrees, orders, letters of instructions, letters of implementation, rules and regulations or part or parts thereof inconsistent with the provisions or any provisions of this Act, are hereby amended, modified, repealed or superseded insofar as they are inconsistent with the provisions of any of this Act.

SECTION 5. **Separability Clause.** If any provisions of this Act or the application of such provision to any person or circumstance is held invalid for any reason, the remainder of this Act or the application of such provision to other persons or circumstances shall not be affected thereby.

SECTION 6. Effectivity. This Act shall take effect immediately upon its approval.
